# Memorandum of Understanding with IBM Academic Initiative

This Memorandum of Understanding ("MOU") is entered into at effective as of Str June 09 ("Effective Date"), by and between:

IBM India Private Ltd., a company incorporated under the provisions of the Companies Act, 1956 and having its registered office at Subramanya Arcade, Bannerghatta Road Bangalore 560076 and hereinafter unless the context otherwise requires be referred to as "IBM".

And

MLR Institute of Technology ("MLRIT") having its registered office at <u>Dundigal</u>, <u>Hyderabad-500043</u>, <u>Andhra Pradesh</u>, and hereinafter unless the context otherwise requires be referred to as "MLRIT"

#### Whereas:

1. MLRIT and IBM have entered into discussions concerning IBM's provision of technology products and services for MLRIT; the parties anticipate that MLRIT will elect to engage IBM as the primary and preferred technology provider for software and services.

Now therefore this MOU witnesses:

### I - DEFINITIONS

"MLR Institute of Technology" hereby refers to MLRIT (Approved by the All India Council for Technical Education (AICTE) and is affiliated to Jawaharlal Nehru Technological University). "Faculty" hereby refers to Training Staff of MLRIT. "Students" hereby refers to all the students of MLRIT.

### II - TERMS AND CONDITIONS

MLRIT hereby agrees and undertakes to perform its obligations under this MoU including the activities as described in Annexure 2 as per the stated timelines.

IBM will perform the Training activities and provide Software as per the details given below and activities as described in Annexure 2.

Under this MOU, MLRIT also assures IBM that it will achieve a target of 100 unique IBM certified students within one (1) year from the effective date of the signing this MoU, to maintain the COF Status. It will also be the endeavor of the college management to help initiate the process of IBM Software to be included in their curriculum in 2009-2010 in case it has not been included so far.

#### Training

During the term of this Agreement, IBM India P Ltd agrees conduct Faculty development programs and Student development programs, free of cost. The Faculty who undergone IBM's Faculty development program, on successful completion will deemed as "Subject Matter Experts" in the respective area. They would then need to train students on their area of expertise. MLRIT

shall work with IBM in advance & select the Faculty development program & Student development program from Annexure 1.

IBM will also conduct certification oriented training program for the Faculty & students and guide them towards free product certification.

#### Software

IBM will provide all IBM Software required for the training programs through the WW Academic Initiative. This software should be used strictly for training & enablement purposes for students & faculty members of MLRIT. No commercial usage is allowed. Software available through the Academic Initiatives program is available in Annexure 1 under applicable IBM International Program License Agreements (IPLA) terms and the provisions of this Understanding

## IV - BREACH OF MOU

In the event of any breach of the terms of this MOU, which is capable of rectification, by either party hereto, such other party shall be entitled to call upon the party to rectify such breach within fifteen days from the date of the notice, failing which the breach shall be deemed to be a material breach, and shall entitle such other party to rescind this MOU for material breach.

## V - TERM AND TERMINATION

The MOU shall be effective from the effective date, and shall be valid for a term of one year, unless terminated earlier by either party, or extended mutually by both parties hereto, on the same terms and conditions as herein.

In the event of termination of this Understanding for any reason whatsoever, including termination due to breach by IBM, the license granted to MLRIT under this understanding, shall also stand automatically terminated without any further act of parties. MLRIT will also return or destroy at our discretion, all material provided by IBM including slides, soft copy courseware provided by IBM towards internal trainings.

The following obligations will survive termination of this MOU for any reason:

Use and nondisclosure of confidential information.

Indemnification and Liability.

Obligations to make payments of amounts that become due under this MOU, by IBM to MLRIT, prior to termination.

#### VI - LIMITATION OF LIABILITY

Neither party shall be liable for any indirect, punitive, special, incidental or consequential damages arising out of or in connection with this Understanding, whether for breach of this MOU or in torts, including loss of business, data, revenue, profits, or for any third party claims against the other (except as specifically admitted by paragraph 2 below) whatsoever.

Except for IBM's obligation to indemnify MLRIT in the event of breach of third Party Intellectual Property rights (as set out in under the Partnerworld Program) and except in the event of breach by MLRIT of any of IBM's Intellectual Property rights, the Parties agree that either Party's liability for any loss or damage to the other, its customers, or any third party, as a result of or in

connection with this Understanding, shall not exceed in the aggregate the amounts received by IBM, from MLRIT under this Understanding.

#### VIII - ARBITRATION

Any and all disputes, controversy or claims related to or arising in connection with this MOU shall first be referred to the Chief Executive Officers of each of the parties for an informal resolution. If this informal resolution does not resolve the dispute, then the matter will be referred to and settled by binding arbitration in accordance with the Arbitration and Conciliation Act, 1996. The status of any such arbitration shall be Chennai. The award of the arbitration may be enforceable in any court of competent jurisdiction. Each party shall bear its own costs and fees in connection with the arbitration.

Unless agreed otherwise, the number of arbitrators shall be three, with each side to the dispute being entitled to appoint one arbitrator. The two arbitrators appointed by the parties shall appoint a third arbitrator who shall act as chairman of the proceedings. Vacancies in the post of chairman shall be filled by the president of the Bar Council of India. Other vacancies shall be filled by the respective nominating party. Proceedings shall continue from the stage they were at when the vacancy occurred. If one of the parties refuses or otherwise fails to appoint an arbitrator within 30 days of the date the other party appoints, the first appointed arbitrator shall be the sole arbitrator. provided that the arbitrator was validly and properly appointed. All proceedings shall be conducted, including all documents presented in such proceedings, in the English language. The English language version of this Agreement prevails over any other language version.

#### IX - GENERAL

This Understanding shall not be construed to be an agency or a partnership or joint venture or an employment relationship. Neither party shall be entitled to bind the other party with any third party by its actions, unless it has specifically obtained the prior written consent of such other party to do so.

Each party is an independent contractor, and nothing under this MOU shall be construed to create an employment relationship, whether for tax or for any other purpose, nor any partnership or join venture between the parties. No provision of this MOU grants either party any express or implied right of authority to assume or create any obligations or responsibility on behalf of or in the name of the other party, or bind the other party in any manner or thing whatsoever. Neither party nor its personnel shall be considered employees of the other.

Neither party shall assign or transfer this Understanding or any benefits or rights or obligations accruing to it under this Understanding, without the prior written consent of the other party

IBM shall during the term of this MOU be entitled to audit the license usage records of licenses hosted on MLRIT competency lab as well as training attendance records maintained by MLRIT. This audit can be conducted only during reasonable business hours.

This MOU supersedes all prior oral or written communication, discussions and representations communicated between the parties hereto in respect of the subject matter of this MOU. Any modification to this MOU shall only be made by way of a written document duly executed by representatives of both parties hereto.

If any provision of this MOU is held to be unenforceable or illegal under certain circumstances for any reason, such decision shall not affect the validity or enforceability of such provisions under other circumstances or the remaining provisions hereof and such provisions shall be reformed only to the extent necessary to make them enforceable under such circumstances.

Any notice under this MOU will be in writing and delivered by hand or by registered mail, return receipt requested, to the other party at the registered office or as may be substituted by the notice. If any notice is sent by mail, notice will be effective on the date of receipt.

MLRIT shall maintain at all times, a one-point contact for the IBM Academic Initiatives. Any change in the contacts below will be promptly notified to IBM.




