PROCEDURE FOR NAME CORRECTION IN GRADE MEMO, CONSOLIDATED GRADE MEMO & PROVISIONAL CERTIFICATE

- (A) Procedure:- For correction or to change the name of Student/Father/Mother in the Grade Memo/Consolidated Grade Memo/ Provisional Certificate issued from MLRITM, a candidate has to submit an application (in prescribed format given below) addressed to the Controller of Examination, MLRITM, mentioning the correction of name in the Grade Memo/ Consolidated Grade Memo/ Provisional Certificate.
- (B) The following documents should be enclosed to the application for correction of name:-
 - 1. All Grade Memos/Consolidated Grade Memo/ Provisional Certificate (if issued) in original.
 - 2. Photocopy of 10th class mark sheet.
 - Payment of Rs. 100/- per grade memo, Rs. 500/- per Consolidated Grade and Rs. 500/- for Provisional Certificate. The payment must be done in student ERP login.
 - 4. Submit the application along with above mentioned documents and online Fee receipt to the following address:
